- If you forget your jersey and you need an extra one from the league you MUST leave your phone number and then return the jersey after the game. We have a limited amount of jerseys, and would appreciate if the extras can be given back. This will help keep the costs of them down.
- All fees MUST be paid in full before the season starts.

ADULT LEAGUE CODE OF CONDUCT

- Lacey Roller Hockey Adult League is a RECREATIONAL League and shall be treated as such. Those individuals that wish to play in a more competitive league are invited to do so.
- Any verbal, physical or sexual abuse of officials, players, spectators or league personnel shall not be tolerated. Failure to follow this rule shall result in game suspensions with no refunds. Violators may also be prosecuted to the fullest extent of the law.
- Fighting shall not be tolerated. First offense one game suspension, second offense two game suspension, third offense season suspension and board approval prior to playing again. No refunds.
- Any disputes between players, teams, officials, etc. shall be subject to twenty-four hour cool down rule. All disputes shall be submitted in writing for review, upon decision of the board if you are not satisfied you may appeal. Please bring all matters to the attention of the Director first.
- No alcohol or drugs of any kind are permitted in rink area at any time. Rink area is considered from curb line of parking lot to rinks and beyond. No Board Member or employee of Lacey Roller Hockey shall be responsible for any illegal activity a player shall commit before, during or after games are played. Players are responsible for their own actions. A referee has the right to eject any player if he/she feels a player is under the influence of alcohol or drugs and may cause harm to themselves or other players.
- All above rules apply before, during and after all games and/or practices at Lacey Roller Hockey.

**PLAYER, WAIVER, RELEASE OF LIABILITY AND INDEMNIFICATION
INSURANCE AGREEMENT**

I, the undersigned player, acknowledge, agree and understand that:

1. Voluntarily and of my own free will, elect to participate in **LACEY ROLLER HOCKEY**. Furthermore, I agree that I am in good health and proper physical condition to participate in **LACEY ROLLER HOCKEY**.
2. I understand that there are certain risks and hazards involved in participating in **LACEY ROLLER HOCKEY** that may result in injury or death to me or other players including, but not limited to those hazards associated with, playing conditions, equipment and other participants.
3. I understand that **ROLLER HOCKEY** is dangerous to me and to other players and may result in serious injury or death.
4. I understand that the very nature of the **SPORT** is hazardous and risky, including but not limited to, the acts of running, jumping, stretching, sliding, diving, skating, collisions with other players and with stationary objects, all of which can cause serious injury or death to me and to other players.

Further, I, the undersigned player, agree that in consideration for the right to play **LACEY ROLLER HOCKEY** and in consideration for permission to play.

1. I voluntarily elect to accept and assume all risks of injury incurred or suffered by me (a) while practicing or playing as a member of the team so designed, (b) while serving in a non-playing capacity as a team member during practice or play by other teams or by other players on my team, and (c) while on or upon the premises of any and all of the ice/surface arranged for by my team or league for practice or play.
2. I hereby release, discharge and agree not to sue **LACEY ROLLER HOCKEY** their owners, officers, agents, servants, associates, employees, referees, coaches, or any person or entity connected with **LACEY ROLLER HOCKEY** for any claim, damages, costs or cause of action which I have or may in the future have as a result of injuries or damages sustained or incurred by me from whatever cause including but not limited to the negligence, breach of contract or wrongful conduct of the parties hereby released.
